The report found that the average cost of car insurance premiums in the nation is \$829.17, a one percent drop from a year ago.

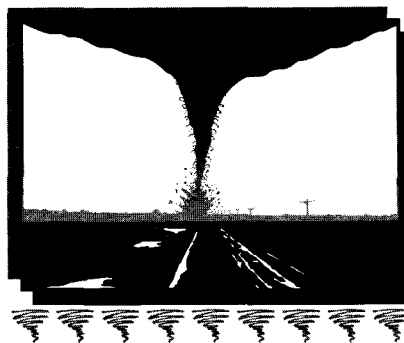
What This Symbol Means To You ...
